The Harrington Park Farmers Market will open Sunday, August 4, 2024, and will run through Sunday, October 6, 2024, from 10am-2pm. The location of the Market is the beautiful Highland Field on Tappan Road in Harrington Park.

Applications may be received via email, mail, or in person. Once accepted by the Market Committee, vendors may participate for the whole or partial season, with advance arrangement. Payment can be made at the Market, or in advance if the vendor wishes.

The Committee will review each application and advise you as to which categories you may sell. If you add any foods or categories not on your original application, please check with the management before selling the items. This request is an effort to be fair to all vendors.

Spaces are larger than a 10' x 10' tent. Vendors are requested to park vehicles behind your tent or table. While the Market is generous with spacing, we reserve the right to charge an additional fee if expansive encroachment occurs.

Vendors are expected to create a neat display with legible signing.

All tents must be weighed down with a minimum of 25 pounds per leg. Highland Field is notorious for its breezy nature, which is enhanced as the weather turns cooler. If you bring a generator, it must be in the rear of your location so there is no noise bothering other vendors or shoppers. These are safety and health concerns, and anyone who does not abide by them may be asked to leave the Market.

Terms and Conditions:

- 1) Vendors must conduct themselves in a professional manner or they will be asked to stop participating in the Farmers Market. Vendors may not “hawk” their wares aggressively throughout the market.
- 2) All vendors shall be set up by 9:45 (set up starts at 8:30 am). Displays must remain open until 2:00 when the Market closes (unless we close due to inclement weather). We are not able to reserve spaces.
- 3) Vendors must comply with all local, state, and federal regulations and health laws. All documents must be submitted with the application. Any food vendors will be inspected by our sanitarian.
- 4) Vendors are responsible for cleaning their areas after the day is over. There is no dumping of food, oil, gasoline products, or other liquids at the Market location.
- 5) Highland Field is a municipal property. Smoking and vaping are prohibited.
- 6) The Borough of Harrington Park prohibits the use of styrofoam containers, plastic straws and stirrers, and single-use plastic bags (Chapter 245 Borough Code).
- 7) The parks and fields of Harrington Park are part of a lightning detection system. If the area is notified by siren that there is lightning in the area, all vendors and shoppers must vacate the area immediately.
- 8) Refunds will be made if the Market is canceled due to health and safety or weather conditions. Vendors can fill out vouchers to receive refunds in these cases.

Termination: The Harrington Park Farmers Market (Business Alliance) reserves the right to terminate the agreement at any time. All terms and conditions shall survive termination. I have read this document and agree to abide by the terms and conditions set forth herein for participation as a vendor in the Market.
