

# Harrington Park Farmers market

The Harrington Park Farmers Market will be opening Sunday, August 20, 2023 and will run through Sunday, October 15, 2023. The location will be at the beautiful Highland Field, from 10am-2pm.

Once accepted by the Market Committee, vendors may participate for the whole or partial season. Applications may be received via email, mail or in person.

In light of fairness and prosperity of all participants, the Business Alliance Farmers Market Committee will review each application and approve of which categories you may sell.

Spaces are larger than a 10' by 10' tent, and vehicles are requested to be parked behind your location. While the Market is generous with spacing, the right is reserved to charge extra if expansive encroachment occurs, negatively impacting other vendors. Each vendor must keep a neat display with legible signage at each location.

All vendor tents must be weighted down with a minimum of 25 pounds per leg. Highland Field is notorious for its breezy nature which is enhanced as the season turns cooler. If a generator is required for function, it must be in the rear of your unit so there is no adverse noise to other vendors and shoppers. Anyone who does not abide by these requests may be asked to leave. These are safety and health concerns.

Terms and Conditions:

- 1) Vendors must conduct themselves in a professional manner or they shall be asked to no longer participate in the Farmers Market.

- 2) All vendors shall be set up prior to 10:00am (set up starting at 8:30am) and must remain open, and on premises, until 2:00pm when the market ends (unless market closed due to inclement weather).
- 3) Vendors must comply to all local, state and federal regulations
- 4) Vendors may not “hawk” their wares in an aggressive manner throughout the market.
- 5) Vendors are responsible for cleaning their area after the market day is over. There is no dumping of food, oil, gasoline products or other liquids at the market site
- 6) There is no smoking or vaping on Municipal property.
- 7) Vendors must comply with the Municipal and Bergen County Health Laws. All appropriate documents must be submitted with your application. Vendors will be inspected by our Municipal Sanitarian.
- 8) There is no reservation of spaces, however, the market will do its best to keep vendors in same spaces and will address any concerns or changes the best way possible.
- 9) Please check with Market Management in advance before adding new food items or categories that were not on your application and previously approved.
- 10) The Borough of Harrington Park prohibits the use of Styrofoam containers, plastic straws, stirrers and single use plastic bags (Chapter 245 Borough Code).
- 11) The parks and fields of Harrington Park are part of a Lightening Detection system. If the area is notified by siren of lightening determined in the area, all must immediately vacate the area.
- 12) Refunds will be made if the market is cancelled due to public health and safety conditions or due to lightening that requires the area to be vacated for extended period of time. Vouchers shall be provide to be filled out and returned for Council approved refund checks.

**Termination:** The Harrington Park Farmers Market (Business Alliance) reserves the right To terminate the agreement at any time. All terms and conditions shall survive termination. I have read the rules and agree to abide by the terms and conditions set forth herein for participation as a vendor in the Market.
